

# **AGREEMENT**

relating to the

## STELLENBOSCH TOURISM LEVY FOR MARKETING STELLENBOSCH

entered into between

## STELLENBOSCH PUBLICITY & MARKETING

(Incorporated under Section 21 of the Companies Act, 1973) (hereinafter referred to as SPM)

And

(hereinafter referred to as the participant)



#### 1. INTRODUCTION

1.1. SPM is a company incorporated in terms of Section 21 of the Companies Act, 1973. It is a distinct legal entity to collect tourism levies which will be used to fund approved marketing projects in the domestic and specific international markets for the benefit of the tourism industry in Stellenbosch.

#### 2. TERMS OF AGREEMENT

- 2.1. The participant agrees to levy upon and collect from its customers / guests / clients a tourism levy of 1,15% (one percent, including 15% VAT)
- The participant undertakes to pay over the collected tourism marketing levies to SPM within 15 (fifteen) days of the end of each accounting month of the participant during which such levies were collected. Each payment shall be accompanied by a completed remittance advice in the form to be provided by SPM, AND an annual confirmation from the participant's accountants/ auditors confirming the these monthly remittances are correct.
- 2.3. This agreement shall commence on the first day of the month following that during which it is signed, and shall continue in perpetuity unless terminated by 3 (three) months written notice by either party provided:
  - **2.3.1.** that the participant furnishes a letter of confirmation from their auditors that they are no longer collecting the levy;
  - **2.3.2.** that SPM notifies the participant in writing of cancellation of this agreement;
- 2.4. This agreement shall remain in force as per clause 2.3 above, unless notified by SPM in writing that the management board of SPM resolves that this project is no longer required and is to be dissolved.



- 2.5. SPM shall be entitled from time to time to require the participant to submit a certificate of the participant's auditors in respect of the tourism levy collected and paid over during any specified period and the basis upon which collection was made. All information furnished to SPM pursuant to this agreement will be treated in the strictest confidence.
- **2.6.** In the event of the participant failing to pay over the prescribed levies as collected, SPM reserves the right to take further action as and when required.
- 2.7. SPM undertakes that all tourism marketing levies (less reasonable operating and administrative charges which in total will not exceed 7,5% [seven and a half percent] of the levies collected. All funds received by it will be held in an interest bearing trust account until such time as they are to be transferred to Visit Stellenbosch or another marketing organisation, for approved projects, as per the agreement in force at the time of transfer.
- 2.8. The recommended wording that should appear against the itemised entry on the consumer account or invoice is "Stellenbosch Tourism Levy".
- 2.9. SPM undertakes each year to make its financial statements available at the Annual General Meeting of the Stellenbosch Publicity and Marketing and to forward a copy thereof to the participant, on request.
- 2.10. The participant chooses domicilium citandi et executandi for all purposes of this agreement, at the address referred to under Section 3 of this agreement, and to which notices may be sent as an alternative to the email address set out in Section 3 of this agreement.
- **2.11.** The parties hereby agree that this agreement supersedes any previous agreement relating to the tourism levy between SPM and the Participant.
